## Rife Biofeedback, Detox & Frequency Support

How Rife Technology Is Understood

Nikola Tesla famously said that if you want to understand the universe, think in terms of energy, frequency, and vibration.

Everything in the body carries a resonant frequency. The working theory behind Rife technology is often explained using a simple analogy: just as an opera singer can shatter a crystal glass by sustaining the precise resonant tone of the glass, specific frequencies can create stress on microorganisms that also operate at identifiable frequencies.

In this model, microorganisms (such as bacteria, fungi, parasites, molds, and viruses) each have a unique frequency. When exposed to that same frequency, structural stress may occur, potentially reducing their activity. Rife resonance waves are designed to interact with these frequencies without harming the user.

Again, this is a theoretical and experimental framework, offered here for informed exploration only.

## 11 Day Full Body System Detox

(Recommended prior to biofeedback scanning)

We recommend completing a full-body detox sequence before targeted frequency sessions. We often liken this process to renovating a long-neglected home: first you clean, then you repair room by room. This program runs continuously over the 11-day period.

## **Biofeedback Scan & Treatment Session**

A biofeedback session involves a full-body scan designed to identify the top frequencies currently placing the most stress on your system.

### **Preparation:**

Please avoid eating for 2 hours prior to your scan for best results.

### **Session Overview:**

After the scan, we proceed with a full-body frequency session targeting the top identified frequencies. TENS pads may be placed on the abdomen or an area of primary concern. Sensations may include tingling, light electrical feelings, or mild discomfort. Some people report fatigue, dizziness, nausea, or general malaise as the body responds and processes. Others notice positive shifts during or after even one session. Every body responds differently.

We often recommend: A 7-day remote program, followed by a new biofeedback scan to reassess and refine next steps.

Please be patient with yourself and your body. States of imbalance often take time to unwind.

### **Pacemakers:**

If you have a pacemaker, we are unable to use this equipment with you. Please speak with us about alternative options.

## **Scalar Frequency Sessions**

Scalar frequency work is based on the understanding that the body communicates through scalar fields. When communication pathways are disrupted, overall system coherence may be affected.

Scalar sessions are designed to support the body's natural ability to reorganize and communicate. Energy is intelligent—it moves where it is needed. Sessions are in person. Duration: 1 hour
